

**South Kentucky RECC is currently accepting resumes for Line Technician
For the Wayne County District Office – Grade 10, Non Exempt**

Qualifications:

High school diploma or equivalent plus five to six years' experience in electrical line work. Must have or have the ability to obtain valid Class A CDL license. The successful candidate will be required to live within 30 minutes (using Google™ Maps) of the Wayne County office and will be required to become part of the on call rotation for the Service Team in Wayne County.

Job Requirements:

Must be personable and friendly and have the ability to promote a positive image of self and the Cooperative. Should also be comfortable dealing with people. Traffic control. Operating equipment in extreme conditions. Frequent work in substations. Assist EKP in switching orders. Building of new lines to consumers and building and maintenance of regular transformer banks. Building and maintenance of capacitor banks and ground, wire, frame and set poles to meet cooperative specifications and assist in framing process. Required to operate bucket trucks and digger truck. Hanging and maintenance of three phase and single phase breakers. Assures all supplies are loaded for each specific job. Construction and installation of primary underground and secondary services. Changing out of 7200 to 14400 hot work. Must be willing to complete SKRECC climbing lab, pole top rescue, CPR/First Aid and any other training/classes that are required as determined immediately or in the future, for the position. May be required to operate GPS unit (Global Positioning System). Must wear all approved safety equipment and clothing/shoes. Must adhere to all safety guidelines as set forth by the Cooperative. Must be accessible and readily available to report to work during on call status. Analyzes work orders and coordinates material needed for daily work. Performs individually all phases of construction, operations and maintenance of energized and de-energized electric lines. Knowledge of voltage requirements and assure they are correct prior to and while working. Required to observe, report and repair conditions perceived to be harmful or potentially harmful to consumers, employees or the general public. Inspect truck thoroughly prior to daily operation (including checking tires, fuel and oil). Operates all Cooperative equipment (including all vehicles) in a safe and efficient manner. Responsible for restoration of services during outages. Must be familiar with ropes, gins, blocks and knot tying. Installs meters, line regulators, oil circuit reclosers and other line equipment. Observes lines for any hazardous conditions that could cause issues; corrects issue or follows up with Team Leader. Assists in clearing right-of-way, digging holes and framing/setting poles and anchors as required. Working knowledge of REA specifications for proper construction of electric facilities. Must be able to complete installation of materials based on specifications. Responsible for training of new employees. Assist consumers by answering questions or addressing concerns. Responsible for assisting with annual inventory. Participates in employee meetings and safety meetings keeping current on first aid procedures. Must be or become familiar with system area and have the ability to use maps. Basic computer skills are required. Other duties as assigned.

Working Conditions:

A scheduled work week is 40 hours. Due to business necessity the work week may periodically exceed 40 hours with work on nights, weekends and holidays possible. Most work will be performed outdoors with some work indoors and possibly in extreme weather conditions.

Physical Requirements:

Ability to load and hang transformers. Ability to load and unload electrical wire and material boxes. Operate bucket trucks, digger trucks, and operate air compressor. This position requires occasional standing and frequent walking. Bending, twisting and reaching are frequent in this position. Climbing the Cooperative's poles is a requirement for this position. Good eye-hand coordination is an essential function of this position. Heavy lifting is required on a daily basis. Must be able to do the following: drive ground rods, fill holes and frame poles.
